The facility was amended and restated with a maturity date of 23 October 2022. The interest rate is a 2.4% p.a margin over BKBM rate. The loan is secured by charges over the NZ properties. Australian Facility This bridge loan facility is with Alceon Group Pty Ltd with a maturity date of 26 September 2022. The interest rate up to 12% annualised, accrued monthly and capitalised.

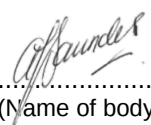
