This fund update was first made publicly available on 3 May 2021.

What is the purpose of this update?

This document tells you how the Smartshares Global Aggregate Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international bonds and is designed to track the return (before tax, fees and other expenses) on the Bloomberg Barclays Global Aggregate Bond Index, hedged to the New Zealand dollar.

Total value of the fund: \$57,545,060

The date the fund started: 6 June 2019

What are the risks of investing?

Risk indicator for the Smartshares Global Aggregate Bond ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Smartshares Global Aggregate Bond ETF are charged fund charges. These are as follows:

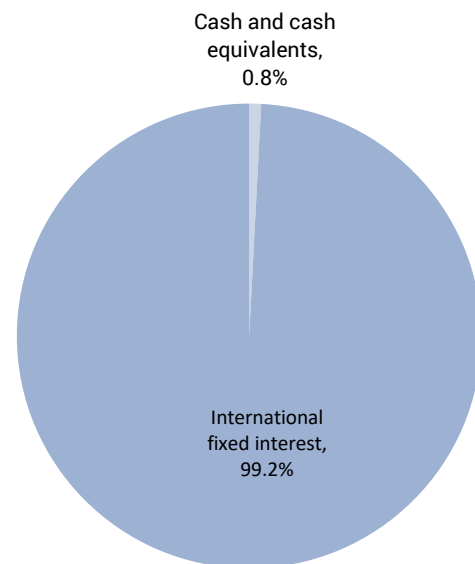
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$92 (that is -0.92% of her initial \$10,000). This gives Tara a total loss after tax of -\$92 for the year.

Notes
