The interest rate is a 3.75% p.a margin over LIBOR. The loan is secured by charges over the property.</p> <p>New Zealand Facility</p> <p>This facility is with Bank of New Zealand (BNZ) and Industrial and Commercial Bank of China (ICBC) and the terms are typical for a secured loan of this nature. The facility was amended and restated with a maturity date of 23 October 2022. The interest rate is a 2.4% p.a margin over BKBM rate. The loan is secured by charges over the NZ properties.</p> <p>Australian Facility</p> <p>This bridge loan facility is with Alceon Group Pty Ltd with a maturity date of 26 September 2022. The interest rate up to 12% annualised, accrued monthly and capitalised.</p>


