Manawa shareholders vote in favour of Scheme

Manawa Energy Limited ("Manawa") advises that the proposed scheme of arrangement under which Contact Energy Limited will, subject to the satisfaction of certain conditions, acquire all of the shares in Manawa (the "Scheme"), has been approved by shareholders at the Scheme Meeting today. In total, 99.97% of all votes cast at the Scheme Meeting and 84.83% of the total voting rights in the company, were in favour of the Scheme.

Details of the voting thresholds required to approve the Scheme, and the voting results are set out below. Copies of the Scheme Meeting materials can be viewed on Manawa's website at <https://www.manawaenergy.co.nz/soa-information>.

The final steps in the Scheme process will now be undertaken, including applying to the High Court for final orders. If the High Court grants final orders approving the Scheme, and subject to the outstanding conditions being satisfied or waived and the Scheme Implementation Agreement not being terminated, the last day of trading in Manawa shares is expected to be 7 July 2025. The record date for participation in the Scheme is expected to be 5.00pm on 9 July 2025 and implementation of the Scheme is expected to occur on 11 July 2025.

Manawa thanks all shareholders for their interest and engagement in the Scheme process.

Voting Results

To proceed, the Scheme required:

- 75% or more of the votes in each interest class who were entitled to vote and who actually voted to have been voted in favour of the Scheme Resolution; and
- more than 50% of the total number of Manawa shares on issue to have been voted in favour of the Scheme Resolution.

At the Scheme Meeting, all shareholders voted in a single interest class and the voting results were as follows:

Scheme Resolution: "That the Scheme (the terms of which are described in the Scheme Booklet) be and is hereby approved."
