PROXY FORM FOR THE 2022 ANNUAL MEETING

Notice is hereby given that the 2022 Annual Meeting of Shareholders of MHM Automation Limited will be held at Chateau on the Park, Tower Room, 189 Deans Avenue, Riccarton, Christchurch 8011 and online at www.virtualmeeting.co.nz/mhm22, on **Thursday, 27 October 2022**, **commencing at 2:00pm** (New Zealand time). If you will attend the Meeting online, you will require your CSN/Holder Number for verification purposes.

If you wish to be represented by proxy, please complete and return this form (in accordance with the lodgement instructions above) to the Company's share registry, Link Market Services Limited, **by no later than 2:00pm, Tuesday, 25 October 2022**. You can also appoint your proxy online by going to https://investorcentre.linkmarketservices.co.nz/voting/mhm or by scanning the QR code above with your smartphone.

APPOINTMENT OF PROXY

If you DO NOT plan to attend the meeting, in person or online, you may appoint a proxy. The proxy need not be a shareholder or Director but the Chair of the meeting or any other Director is willing to act as proxy for any shareholder who appoints him or her for that purpose. If, in appointing your proxy, you do not name a person as your proxy, or your named proxy does not attend the meeting, the Chair of the meeting will be your proxy and may vote only in accordance with your express direction.

VOTING OF YOUR HOLDING

Direct your proxy how to vote by making the appropriate election, on this Proxy Form, in respect of the item of business (Resolution 1 to 4). If you do not make an election in respect of that resolution your proxy may vote as they choose. If you make more than one election in respect of the resolution your vote will be invalid on that resolution.

PROXY DISCRETION

If you expressly appoint the Chair of the meeting or any other Director as your proxy and elect to give them discretion on how to vote on a resolution, you acknowledge that they may exercise your vote even if they have an interest in the outcome of that resolution.

The Chair of the meeting and the Directors intend to vote all discretionary proxies in favour of the resolution.

VOTING RESTRICTIONS

Pursuant to NZX Listing Rule 6.3.1, the Company will disregard any votes on Resolution 3 by any Director of the Company and any associated person of any Director of the Company, except where any such vote is cast by the Director or one of their associates as proxy for a person who is qualified to vote and only in accordance with that person's express instructions.

ATTENDING THE MEETING

If you wish to vote in person you should attend the meeting. Please bring this form with you to the Meeting to assist with your registration. A corporation may appoint a person to attend and vote at the Meeting as its representative in the same manner as that in which it could appoint a proxy. That person need not also be a shareholder.

SIGNING INSTRUCTIONS FOR PROXYFORMS

Individual

Where the holding is in one name, the security holder must sign.

Joint holding

Where the holding is in more than one name, either of the joint holders (or their duly authorised attorney) may sign this Proxy form.

Company

This Proxy Form must be signed by a duly authorised officer or attorney. Persons who sign on behalf of a company must be acting with the company's express or implied authority.

Power of Attorney

If this Proxy Form has been signed by an attorney, a copy of the power of attorney under which it was signed (if not previously provided to the Registrar), and a signed certificate of non-revocation of the power of attorney must accompany this Proxy Form.
