### What is the purpose of this update?

Potentially lower return

## What fees are investors charged?

### Example of how this applies to an investor


Tara had \$10,000 in the fund on 24 October 2024 and did not make any further contributions. On 31 December 2024, Tara received a return after fund charges were deducted but before tax of \$298 (that is 2.98% of Tara's initial \$10,000). This gives Tara a total return after tax of \$346 for the period.

#### **Currency hedging**

As at 31 December 2024 the fund's exposure to assets denominated in foreign currencies was 99.83%, of which 100.81% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund. ### Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 4 years and 10 months of market index returns.
- 2 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
