3.0 - CHANGES RELATING TO THE SCHEME

Governing Document

There were no changes to the Scheme's Governing Document for the financial year ended 31 March 2025.

Terms of the Offer

The Scheme's Product Disclosure Statement (PDS) was updated on 7 May 2024 to include the following changes:

- i. Change of the Carbon Fund's risk indicator from '7' to '6' in sections 1 and 3, and
- ii. Change of the Custodian to Apex Investment Administration (NZ) in section 7.

Statement of investment policy and objectives (SIPO)

There were no changes to the Scheme's SIPO for the financial year ended 31 March 2025.

Related party transactions

As at 31 March 2025, Salt Funds Management Limited held 1,601 units, or 0.003% of the Fund (31 March 2024: 1,601 units, or 0.003% of the Fund). During the year, Salt Funds Management Limited did not trade any units in the Fund.

As at 31 March 2025, Salt Long Short Fund held 757,500 units, or 1.61% of the Fund (31 March 2024: 757,500 units, or 1.61% of the Fund). During the year, the Salt Long Short Fund did not trade any units in the Fund.

As at 31 March 2025, Salt Sustainable Growth Fund held 543,726 units, or 1.15% of the Fund (31 March 2024: 543,726 units, or 1.15% of the Fund). During the year, the Salt Sustainable Growth Fund did not trade any units in the Fund.
