## **Smartshares Global Bond ETF**

#### Fund update for the quarter ended 31 March 2022

This fund update was first made publicly available on 3 May 2022.

## What is the purpose of this update?

This document tells you how the Smartshares Global Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in international bonds, with the objective of outperforming the Bloomberg Global Aggregate Bond Index by 1% per annum over rolling 3-year periods, hedged to the New Zealand dollar. The investment manager is PIMCO Australia Pty Ltd.

## What are the risks of investing?

### Risk indicator for the Smartshares Global Bond ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

## How has the fund performed?



#### Annual return graph


## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$311 (that is -3.11% of her initial \$10,000). This gives Tara a total loss after tax of -\$311 for the year.

### **Currency hedging**

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements).
