On behalf of the directors of Greenfern Industries Limited (**Greenfern**), I am pleased to offer Eligible Shareholders the opportunity to participate in this approximately NZ\$5 million Rights Issue (the **Offer**) of new ordinary shares in Greenfern (**New Shares**). The Offer is now open for applications.

Under the Offer, Eligible Shareholders may apply for 1 New Share for every 1.3736 existing shares in Greenfern held by them on the Record Date, at the Issue Price of NZ\$0.08 (the **Rights**).

Eligible Shareholders are all persons who were shareholders recorded on Greenfern's register at 5:00pm (NZDT) on Monday, 10 October 2022 that:

There will be no bookbuild, and those shareholders who do not take up their Rights in full will have their holding diluted.
