### Fund update for the quarter ended 31 March 2021

This fund update was first made publicly available on 3 May 2021.

### What is the purpose of this update?

This document tells you how the Smartshares US Large Growth ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in US shares and is designed to track the return (before tax, fees and other expenses) on the CRSP US Large Cap Growth Index.

Total value of the fund: \$117,915,857

The date the fund started: 29 July 2015

### What are the risks of investing?

#### Risk indicator for Smartshares US Large Growth ETF

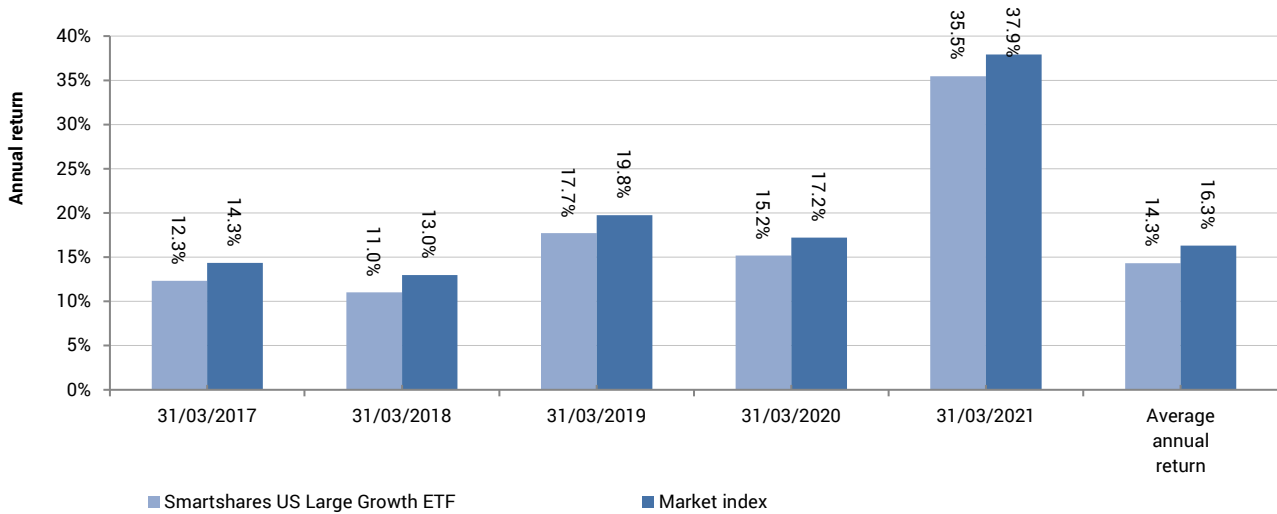

## What fees are investors charged?

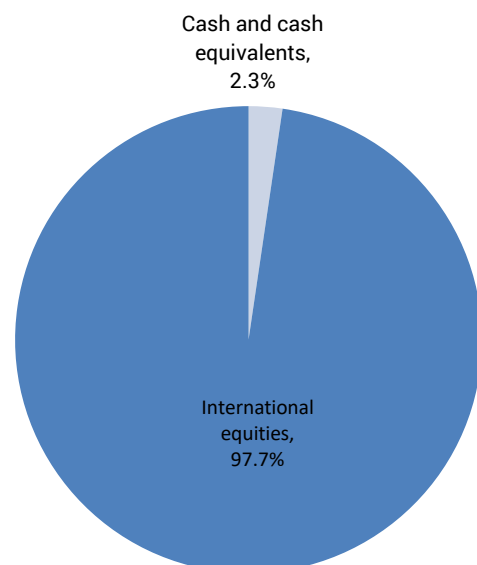
## Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$3,547 (that is 35.47% of her initial \$10,000). This gives Tara a total return after tax of \$3,547 for the year.
