What is the purpose of this update?

Description of this fund

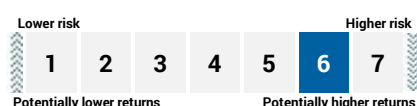
Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 Index.

Total value of the fund: \$102,435,431

What are the risks of investing?

Risk indicator for the Smartshares S&P/ASX 200 ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

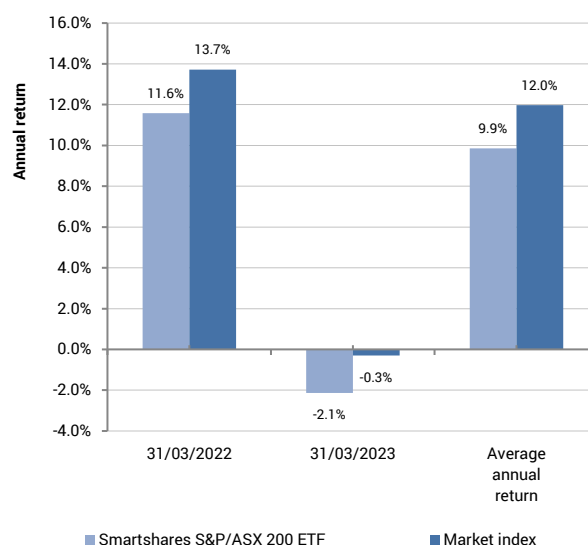

How has the fund performed?

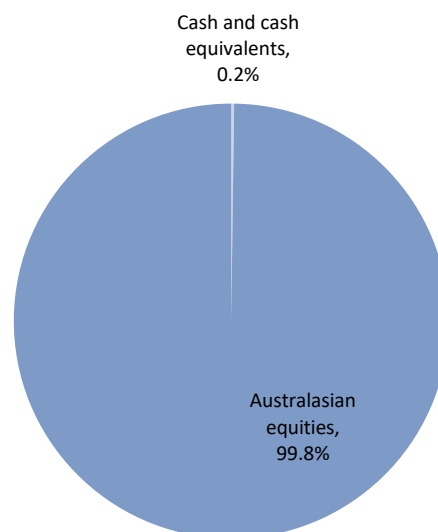
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$214 (that is -2.14% of her initial \$10,000). This gives Tara a total loss after tax of -\$214 for the year.

Notes

- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
