### Fund update for the quarter ended 31 March 2022

This fund update was first made publicly available on 3 May 2022.

### What is the purpose of this update?

This document tells you how the Smartshares S&P/NZX NZ Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in New Zealand bonds and is designed to track the return (before tax, fees and other expenses) of the S&P/NZX NZ Government Bond Index.

Total value of the fund: \$215,681,388  
 The date the fund started: 15 July 2020

### What are the risks of investing?

#### Risk indicator for the Smartshares S&P/NZX NZ Government Bond ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

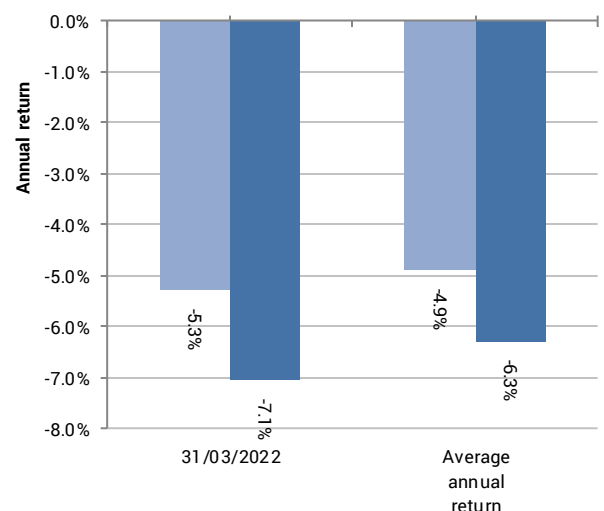

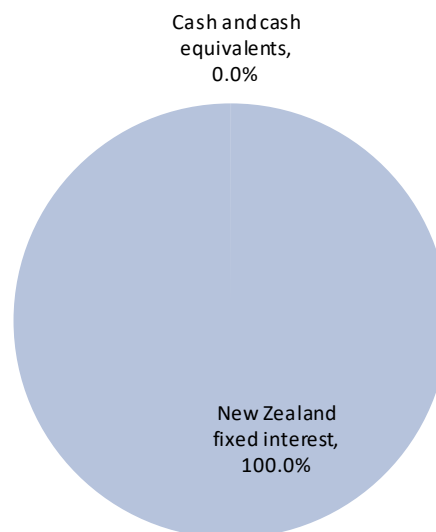
### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$530 (that is -5.30% of her initial \$10,000). This gives Tara a total loss after tax of -\$530 for the year.

## Notes

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
