What is the purpose of this update?

Description of this fund

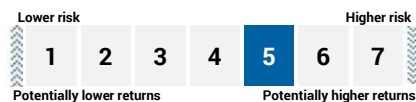
Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the MSCI World ex Australia Custom ESG Leaders Index.

Total value of the fund: \$145,412,667

What are the risks of investing?

Risk indicator for the Smartshares Global Equities ESG ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

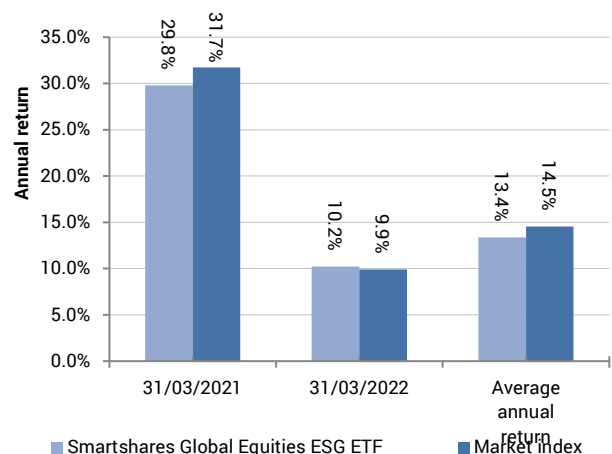
How has the fund performed?

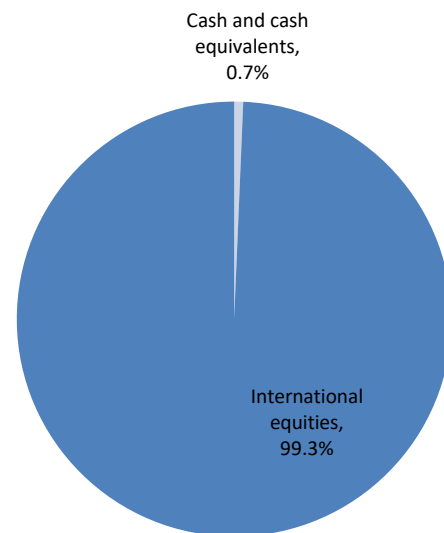
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$1,021 (that is 10.21% of her initial \$10,000). This gives Tara a total return after tax of \$1,021 for the year.

Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 3 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
