

# **Smart NZ Property ETF**

#### Fund update for the quarter ended 31 March 2025

This fund update was first made publicly available on 1 May 2025.

### What is the purpose of this update?

This document tells you how the Smart NZ Property ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Smart NZ Property ETF is designed to track the return (before tax, fees and other expenses) of the S&P/NZX Real Estate Select Index. The Index is comprised of the largest and most liquid members of the S&P/NZX All Index classified under the GICS Real Estate Industry Group.




# How has the fund performed?

# What fees are investors charged?

Small differences in fees and charges can have a big impact on your investment over the long term.

### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of -\$682 (that is -6.82% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$739 for the year.
