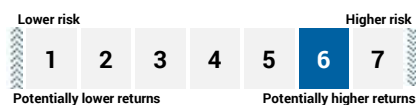
Description of this fund

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) on the S&P/ASX 20 Index.

Total value of the fund: \$165,355,657

What are the risks of investing?

Risk indicator for the Smartshares Australian Top 20 ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

time. The risk indicator will continue to be updated in future fund updates.

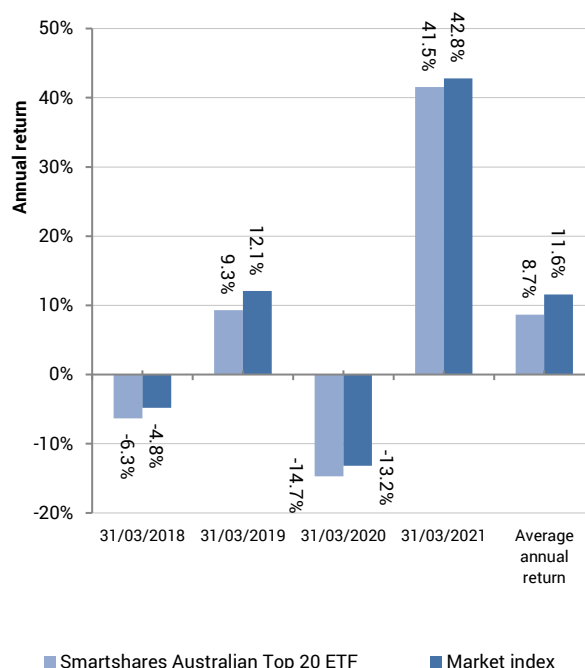

How has the fund performed?

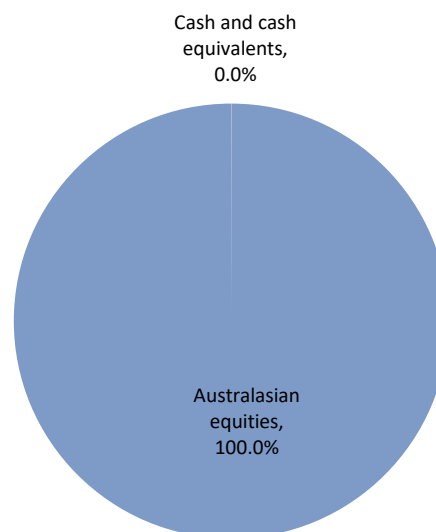
Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$4,153 (that is 41.53% of her initial \$10,000). This gives Tara a total return after tax of \$4,153 for the year.
