#### Fund update for the quarter ended 31 March 2021

This fund update was first made publicly available on 3 May 2021.

### What is the purpose of this update?

This document tells you how the Smartshares NZ Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in New Zealand shares and is designed to track the return (before tax, fees and other expenses) on the S&P/NZX Mid Cap Index.

## What are the risks of investing?

#### Risk indicator for the Smartshares NZ Mid Cap ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

time. The risk indicator will continue to be updated in future fund updates.




## Example of how this applies to an investor

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$4,140 (that is 41.40% of her initial \$10,000). This gives Tara a total return after tax of \$4,140 for the year.

### **Notes**

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 8 months of market index returns.
- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
