MARLBOROUGH WINE ESTATES GROUP (MWE)

- Producing high quality wines which attain global recognition
- Own and operate six vineyard blocks, on over 330 hectares, in Marlborough, New Zealand's largest wine region
- Producing some of New Zealand's finest Marlborough Sauvignon Blancs under the OTU and Music Bay brands
- Multiple, international wine awards for OTU Sauvignon Blanc
- Distribution relationships in 10 countries internationally, including Australia, Canada, China, Ireland, United Kingdom, and the USA









2021 and 2022 HARVESTS

- 2021 harvest was low yielding but exceptionally high quality resulting in highly rated wines which became available for sale in FY22
- 2022 harvested volumes up 35% on prior year (12% above expectations)
- increased the quantity of grapes sold in 2022 while retaining sufficient inventory to meet MWE's branded wine demand and further grow the distribution platform

FY22 OVERVIEW

FURTHER SOLID PROGRESS ON BRANDED WINE AND PREMIUMISATION STRATEGIES

- International branded wine sales revenue increased 117%
- Signed new distribution agreements with distribution partners in the US, UK and Ireland
- Expansion in distribution in New Zealand market
- Return to profitability and significant improvement to EBITDA

FY22 FINANCIAL SNAPSHOT

- Branded wine sales: +16% YOY to \$4.49M
- Total Sales: +18% YOY to \$7.96m
- Bulk Grape and wine sales: \$3.47m
- Return to Profit, Net Profit After Tax: \$0.33m
- \$1.6M uplift in Adjusted EBITDA




