Fund update for the quarter ended 31 March 2022

This fund update was first made publicly available on 3 May 2022.

What is the purpose of this update?

This document tells you how the Smartshares Total World (NZD Hedged) ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) of the FTSE Global All Cap Index, 100% NZD hedged.

Total value of the fund: \$77,921,722
The date the fund started: 15 July 2020

What are the risks of investing?

Risk indicator for the Smartshares Total World (NZD Hedged) ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

Note that even the lowest category does not mean a riskfree investment, and there are other risks that are not captured by this rating. 

How has the fund performed?


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$704 (that is 7.04% of her initial \$10,000). This gives Tara a total return after tax of \$704 for the year.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2022, 95.35% of the fund's foreign currency exposure was hedged.

Notes

- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
