### What is the purpose of this update?

This document tells you how the Smart US 500 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Smart US 500 ETF is designed to track the return (before tax, fees and other expenses) of the S&P 500 Index. The Index is comprised of 500 of the largest listed companies in the United States.

## What are the risks of investing?

#### Risk indicator for the Smart US 500 ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.


# **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,244 (that is 12.44% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,096 for the year.
