# What is the purpose of this update?

This document tells you how the Smart US Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. # **Description of this fund**

The Smart US Mid Cap ETF is designed to track the return (before tax, fees and other expenses) of the CRSP US Mid Cap Index. The Index is comprised of midsize US companies.

# What are the risks of investing?

#### Risk indicator for the Smart US Mid Cap ETF




# Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$2,871 (that is 28.71% of Tara's initial \$10,000). This gives Tara a total return after tax of \$2,706 for the year.
