This fund update was first made publicly available on 1 May 2025.

### What is the purpose of this update?

This document tells you how the Smart Global ESG ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Smart Global ESG ETF is designed to track the return (before tax, fees and other expenses) of the MSCI World Ex Australia Custom ESG Leaders Net Total Return Index.

The Index is comprised of global companies screened for exposure to controversial weapons, civilian firearms, tobacco, thermal coal and oil sands. The Index excludes companies that fail to

comply with the United Nations Global Compact Principles. For more information, please refer to the Smart Responsible Investment Policy.

### What are the risks of investing?

#### Risk indicator for the Smart Global ESG ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




### How has the fund performed?


### Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$751 (that is 7.51% of Tara's initial \$10,000). This gives Tara a total return after tax of \$614 for the year.
