### Fund update for the quarter ended 31 December 2022

This fund update was first made publicly available on 10 February 2023.

### What is the purpose of this update?

This document tells you how the Smartshares Australian Mid Cap ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX Mid Cap 50 Index.

Total value of the fund: \$157,969,029

The date the fund started: 7 November 2016

### What are the risks of investing?

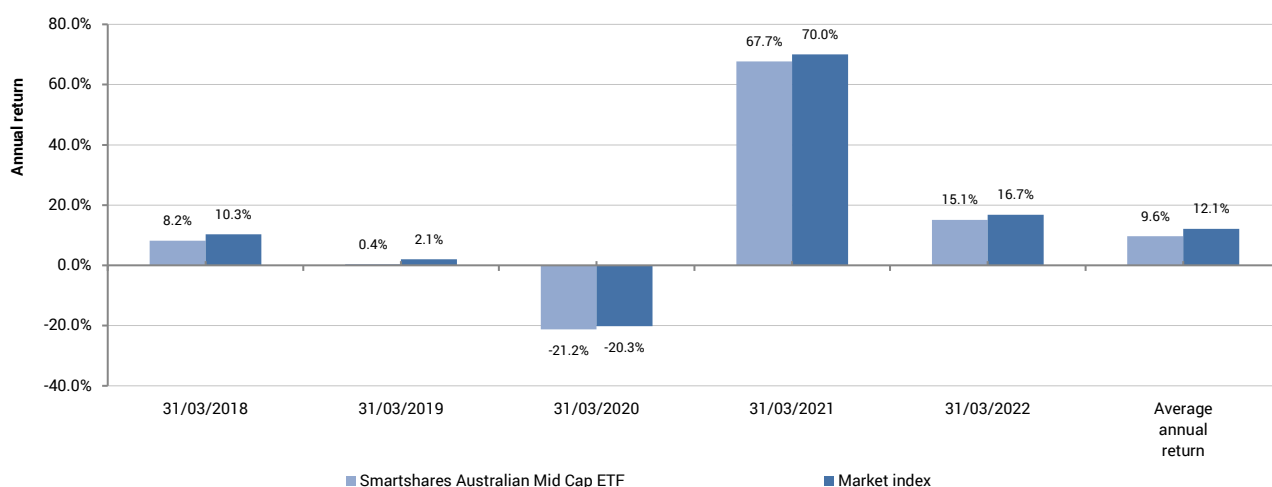

## Annual return graph

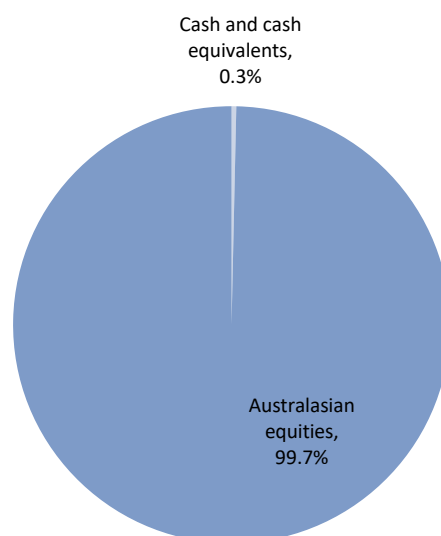
## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$706 (that is -7.06% of her initial \$10,000). This gives Tara a total loss after tax of -\$706 for the year.
