
## **Description of this fund**

The Smart Australian Property ETF is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 A-REIT Equal Weight Index. The Index equally weights the constituents of the S&P/ASX 200 A-REIT Index, which is comprised of Australian Real Estate Investment Trusts (A-REITs) and mortgage REITs.

# Risk indicator for the Smart Australian Property ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.




## How has the fund performed?

#### **Annual return graph**

## What fees are investors charged?

Investors in the Smart Australian Property ETF are charged fund charges. In the year to 31 March 2024 these were:

Small differences in fees and charges can have a big impact on your investment over the long term.

## Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$3,378 (that is 33.78% of Tara's initial \$10,000). This gives Tara a total return after tax of \$3,219 for the year.
