What is the purpose of this update?

This document tells you how the Smart Emerging Markets ESG ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Smart Emerging Markets ESG ETF is designed to track the return (before tax, fees and other expenses) of the MSCI EM IMI ESG Screened Index.

The Index is comprised of emerging markets companies screened for exposure to controversial weapons, civilian firearms, tobacco, thermal coal and oil sands. The Index excludes companies that

fail to comply with the United Nations Global Compact Principles. For more information, please refer to the Smart Responsible Investment Policy.

What are the risks of investing?

Risk indicator for the Smart Emerging Markets ESG ETF




How has the fund performed?

What fees are investors charged?

Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,986 (that is 19.86% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,837 for the year.
