Description of this fund


The Smart Automation and Robotics ETF is designed to track the return (before tax, fees and other expenses) of the iSTOXX® FactSet Automation & Robotics Index. The Index is comprised of stocks from developed and emerging market companies from sectors

associated with the development of automatic and robotic technology.

What are the risks of investing?

Risk indicator for the Smart Automation and Robotics ETF




How has the fund performed?

What fees are investors charged?

Small differences in fees and charges can have a big impact on your investment over the long term.

Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$1,816 (that is 18.16% of Tara's initial \$10,000). This gives Tara a total return after tax of \$1,661 for the year.
