# TWL Annual General Shareholders' Meeting Results 2024

### 22 August 2024

At Trade Window Holdings Limited's (NZX: TWL) Annual General Shareholders' Meeting held online today, shareholders were asked to vote on eight ordinary resolutions. All voting was conducted by a poll, as required by NZX Listing Rule 6.1. The resolutions passed by shareholders and as set out in full in the Notice of Meeting were:
