What is the purpose of this update?

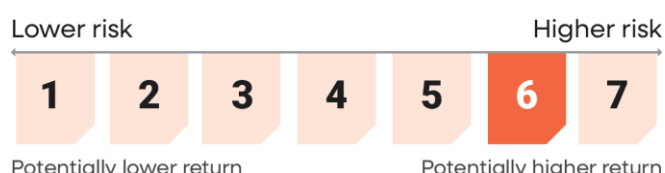
Description of this fund

The Smart US Small Cap ETF is designed to track the return (before tax, fees and other expenses) of the CRSP US Small Cap Index. The Index is comprised of small US companies.

What are the risks of investing?

Risk indicator for the Smart US Small Cap ETF



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

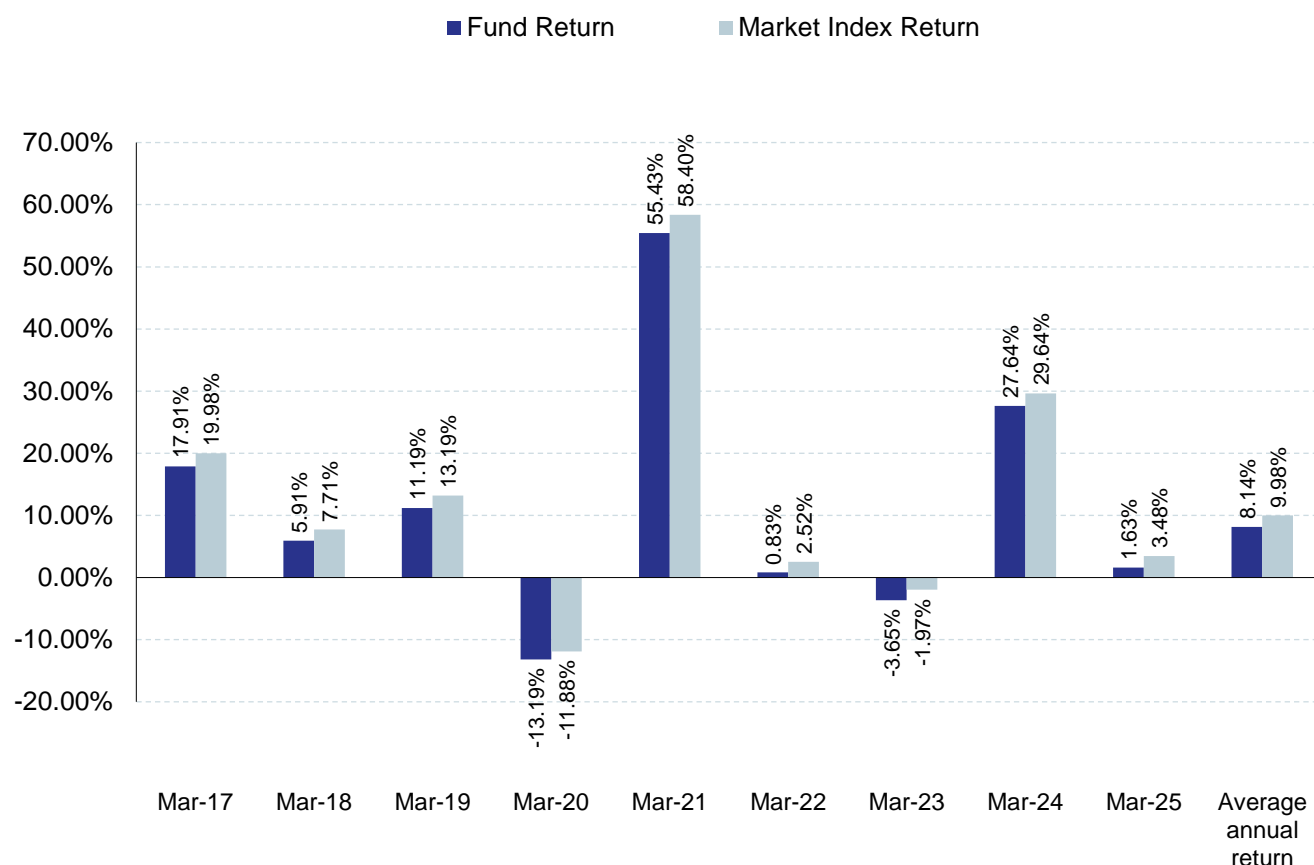

How has the fund performed?

What fees are investors charged?

Investors in the Smart US Small Cap ETF are charged fund charges. In the year to 31 March 2024 these were:

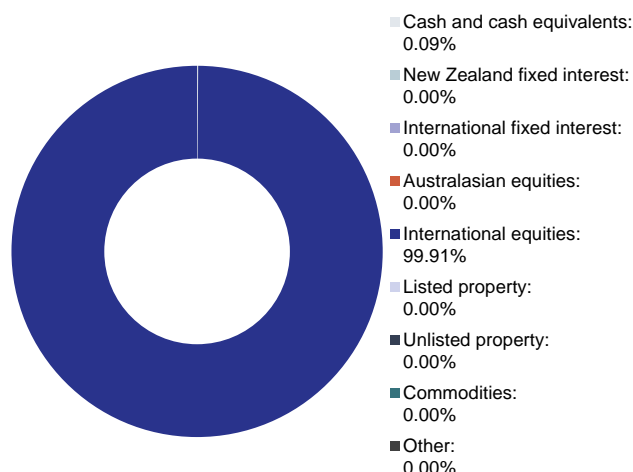
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$295 (that is 2.95% of Tara's initial \$10,000). This gives Tara a total return after tax of \$163 for the year.
