

# Smart US 500 (NZD Hedged) ETF

#### Fund update for the quarter ended 30 September 2024

This fund update was first made publicly available on 29 October 2024.

## What is the purpose of this update?

This document tells you how the Smart US 500 (NZD Hedged) ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### **Description of this fund**

The Smart US 500 (NZD Hedged) ETF is designed to track the return (before tax, fees and other expenses) of the S&P 500 Dynamic Hedged NZD Index. The Index is comprised of 500 of the largest listed companies in the United States. The currency exposure is hedged to the New Zealand dollar.

# What are the risks of investing?

# What fees are investors charged?

Investors in the Smart US 500 (NZD Hedged) ETF are charged fund charges. Based on the Product Disclosure Statement dated 10 October 2024, these are expected to be:

### Example of how this applies to an investor


Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted but before tax of \$3,368 (that is 33.68% of Tara's initial \$10,000). This gives Tara a total return after tax of \$3,010 for the year.

### **Currency hedging**

As at 30 September 2024 the fund's exposure to assets denominated in foreign currencies was 99.58%, of which 97.08% was hedged. This means the fund's unhedged foreign currency exposure was 2.91% of the net asset value of the fund. ### Notes

- 1 Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 9 months of market index returns.
- 2 These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
- 3 The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
