This fund update was first made publicly available on 3 May 2021.

What is the purpose of this update?

This document tells you how the Smartshares Total World (NZD Hedged) ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international shares and is designed to track the return (before tax, fees and other expenses) on the FTSE Global All Cap Index.

Total value of the fund: \$50,300,835
The date the fund started: 15 July 2020

What are the risks of investing?

Risk indicator for the Smartshares Total World (NZD Hedged) ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Smartshares Total World (NZD Hedged) ETF are charged fund charges. These are as follows:


Example of how this applies to an investor

Tara had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 March 2021, Tara received a return after fund charges were deducted of \$2,129 (that is 21.29% of her initial \$10,000). This gives Tara a total gain after tax of \$2,121 for the 8 months and 15 days.

Currency hedging

The fund's foreign currency exposure is hedged to the New Zealand dollar. The target hedging level is 100% (although the actual hedging level may differ from this because of cash flow and market movements). As at 31 March 2021, 99.30% of the fund's foreign currency exposure was hedged.

Notes
