Fund update for the quarter ended 30 September 2022

This fund update was first made publicly available on 31 October 2022.

What is the purpose of this update?

This document tells you how the Smartshares Global Aggregate Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in international bonds and is designed to track the return (before tax, fees and other expenses) of the Bloomberg Global Aggregate Bond Index, hedged to the New Zealand dollar.

Total value of the fund: \$158,426,930

The date the fund started: 6 June 2019

What are the risks of investing?

Risk indicator for the Smartshares Global Aggregate Bond ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

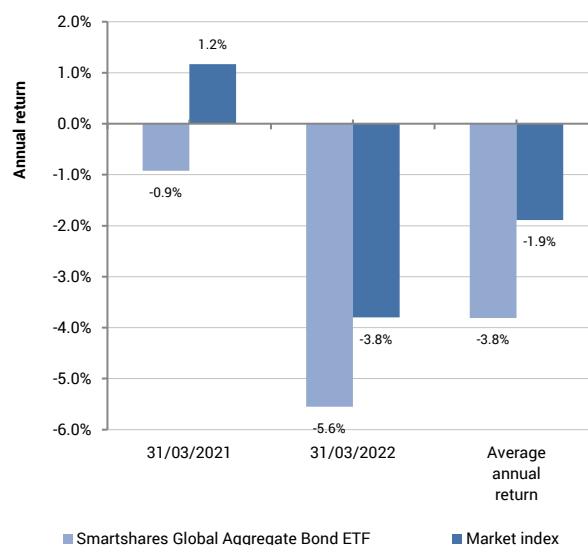

How has the fund performed?

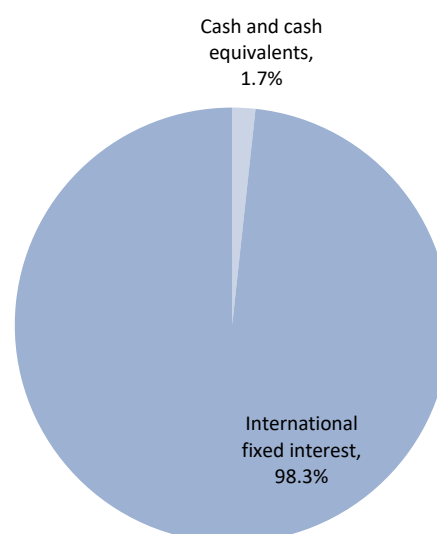
Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$1,392 (that is -13.92% of her initial \$10,000). This gives Tara a total loss after tax of -\$1,392 for the year.

Notes

- 2 We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
