# What is the purpose of this update?

This document tells you how the Smartshares Europe Equities ESG ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## **Description of this fund**

Invests in European shares and is designed to track the return (before tax, fees and other expenses) on the MSCI Europe ESG Screened Index.

## What are the risks of investing?

Risk indicator for the Smartshares Europe Equities ESG ETF<sup>1</sup>



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

# What fees are investors charged?

Investors in the Smartshares Europe Equities ESG ETF are charged fund charges. These are as follows:


## **Example of how this applies to an investor**

Tara had \$10,000 in the fund and did not make any further contributions. At the end of the year, Tara received a return after fund charges were deducted of \$2,315 (that is 23.15% of her initial \$10,000). This gives Tara a total return after tax of \$2,315 for the year.

#### **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 3 years and 3 months of market index returns.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges.
- The top 10 investments listed in the table exclude current assets and current liabilities, and as a result do not sum to 100%.
