


Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$961 (that is -9.61% of her initial \$10,000). This gives Tara a total loss after tax of -\$961 for the year.
