# What is the purpose of this update?

This document tells you how the Smartshares S&P/ASX 200 ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

Invests in Australian shares and is designed to track the return (before tax, fees and other expenses) of the S&P/ASX 200 Index.

Total value of the fund: \$98,463,482

# What are the risks of investing?

Risk indicator for the Smartshares S&P/ASX 200 ETF1



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.



# How has the fund performed?

# What fees are investors charged?

Investors in the Smartshares S&P/ASX 200 ETF are charged fund charges. In the year to 31 March 2022 these were:


# **Example of how this applies to an investor**

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted of -\$238 (that is -2.38% of her initial \$10,000). This gives Tara a total loss after tax of -\$238 for the year.

### **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 7 months of market index returns.
- We charge fixed fund charges that cover normal fund operating costs. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. This may be shown as 0.00% due to rounding.
