## On-market purchase of ANZ shares to settle employee compensation schemes

ANZ Group Holdings Limited (**ANZ**) advises that ANZEST Pty Ltd (**ANZEST**) intends to purchase on-market up to approximately \$140 million of ANZ shares in order for ANZEST to settle certain amounts due under ANZ's share-based compensation plans. The purchase is intended to mainly occur in November and December 2024 (outside of the pricing period for ANZ's Dividend Reinvestment Plan (DRP) between 19 November and 2 December 2024 (inclusive)).

UBS Securities Australia Limited will be instructed to execute the purchase.

To the extent that the on-market purchase is not able to be completed for any reason, then ANZ will issue new shares to enable ANZEST to settle the amounts due.
