This fund update was first made publicly available on 29 October 2025.

### What is the purpose of this update?

This document tells you how the Smart Global Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

# **Description of this fund**

The Smart Global Government Bond ETF is designed to provide returns (before tax, fees and other expenses) consistent with the Bloomberg Global Aggregate Treasuries Total Return Index (100% NZD Hedged).

The Index is comprised of sovereign debt of investment grade countries, including both developed and emerging markets. The

investment manager is BlackRock Investment Management (Australia) Limited. The currency exposure is hedged to the New Zealand dollar.

# What are the risks of investing?

Risk indicator for the Smart Global Government Bond ETF<sup>1</sup>




# How has the fund performed?

# What fees are investors charged?

# Example of how this applies to an investor

Tara had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Tara incurred a loss after fund charges were deducted but before tax of -\$27 (that is -0.27% of Tara's initial \$10,000). This gives Tara a total loss after tax of -\$5 for the year.

### **Currency hedging**

As at 30 September 2025 the fund's exposure to assets denominated in foreign currencies was 100.00%, of which 100.00% was hedged. This means the fund's unhedged foreign currency exposure was 0.00% of the net asset value of the fund. ### **Notes**

- Market index returns (as well as actual returns) have been used to complete the risk indicator, as the fund has not been in existence for 5 years. As a result, the risk indicator may provide a less reliable indicator of the potential future volatility of the fund. The risk indicator for the fund uses 2 years and 9 months of market index returns.
- These charges refer to the normal fund operating costs that are charged to the fund. For disclosure purposes, supervisor, audit and legal costs are not included in the manager's basic fee, but are included in the other management and administration charges. Some of these are fixed costs so the amount shown can range from 0% up to the total fund charges depending on the total value of the fund.
