This fund update was first made publicly available on 3 May 2021.

What is the purpose of this update?

This document tells you how the Smartshares S&P/NZX NZ Government Bond ETF has performed and what fees were charged. The document will help you to compare the fund with other funds. Smartshares Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Invests in New Zealand bonds and is designed to track the return (before tax, fees and other expenses) on the S&P/NZX NZ Government Bond Index.

Total value of the fund: \$38,286,596

The date the fund started: 15 July 2020

What are the risks of investing?

Risk indicator for the Smartshares S&P/NZX NZ Government Bond ETF¹



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

What fees are investors charged?

Investors in the Smartshares S&P/NZX NZ Government Bond ETF are charged fund charges. These are as follows:

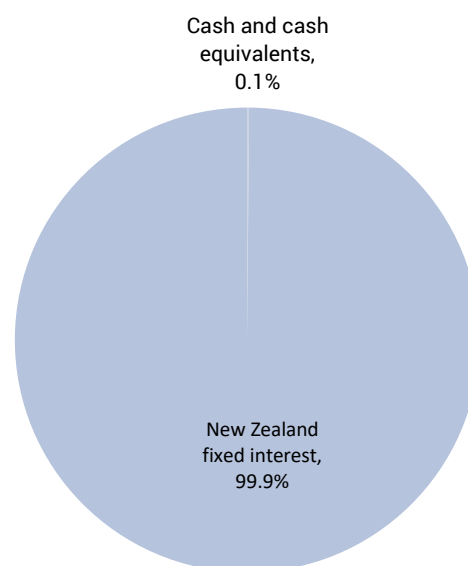
Example of how this applies to an investor

Tara had \$10,000 in the fund on 15 July 2020 and did not make any further contributions. On 31 March 2021, Tara received a return after fund charges were deducted of \$-254 (that is -2.54% of her initial \$10,000). This gives Tara a total loss after tax of \$-262 for the 8 months and 15 days.
